- Inertial measurement unit (IMU);
- Birth Date; Height; Weight; Competition gender, Competition start date;
- Name, surname, email.

b. Through our website (community subscription):

- First name;
- Last name;
- Email address.

3. How We Use Your Data

We use your data <u>exclusively</u> for the following purposes:

- To provide and enhance the functionality of our device and application.
- To allow you to monitor your health and physical performance.

• Send updates, news, and relevant information through our channels (subject to your consent).

4. Legal Basis for Processing

We process your personal data based on the following legal grounds under the GDPR:

- Explicit consent (Art. 6(1)(a)) Newsletter subscription;
- Performance of a contract (Art. 6(1)(b)) Providing and operating the application and device. IMEI and other data, certificate from the device, GPS or Location
- Processing of special categories of personal data (health data) based on explicit consent (Art. 9(2)(a)).
- Legitimate interests (Art. 6(1)(f)) Use of data to improve the algorithm.

5. Data Sharing

We do not currently share your personal information with third parties. We will communicate any future changes to you in advance.

6. Data Security

We have implemented appropriate technical and organizational measures to protect your data against unauthorized access, alteration, disclosure, or destruction.

7. Data Retention

We retain your personal data only for as long as necessary to fulfill the purposes for which the data was collected and as required by applicable law.
